2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

DANGER. CORROSIVE. CAUSES IRREVERSIBLE EYE DAMAGE. CAUSES EYE AND SKIN BURNS. MAY BE FATAL IF ABSORBED THROUGH SKIN. HARMFUL OR FATAL IF SWALLOWED.

Principle routes of exposure: Eye contact. Skin contact. Inhalation. Ingestion.
Eye contact: Corrosive. Causes irreversible eye damage. Causes permanent eye damage, including blindness.
Skin contact: Corrosive. May cause permanent damage. Harmful if absorbed through skin .
Inhalation: May cause irritation and corrosive effects to nose, throat and respiratory tract.
Ingestion: Corrosive. May cause burns to mouth, throat and stomach .

4. FIRST AID MEASURES

Eye contact: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Get medical attention immediately.

Skin contact: Take off contaminated clothing. Flush immediately with plenty of water for at least 15 minutes. Get medical attention immediately.

Inhalation: If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and then give artificial respiration, preferably by mouth to mouth, if possible. Get medical attention immediately.

Ingestion: Call medical attendant, doctor, or poison control center immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Never give anything by mouth to an unconscious person. Get medical attention immediately.

Notes to physician: Probable mucosal damage may contraindicate the use of gastric lavage.

Aggravated Medical Conditions: Individuals with chronic respiratory disorders such as asthma, chronic bronchitis, emphysema, etc., may be more susceptible to irritating effects.

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media: Dry chemical, water spray, foam, carbon dioxide.
Specific hazards: None known.
Unusual hazards: Corrosive material (See sections 8 and 10).
Specific methods: No special methods required.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Put on appropriate personal protective equipment (see Section 8.).

7. HANDLING AND STORAGE

Remove and wash contaminated clothing and footwear before re-use. Wash thoroughly after handling. Product residue may remain on/in empty containers. Storage: Keep tightly closed in a dry, cool and well-ventilated place. Protect from freezing. Store in a cool, dry, well ventilated area away from heat or open flame. Keep out of the reach of children.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

Engineering measures to reduce exposure: Good general ventilation should be sufficient to control airborne levels. Respiratory protection is not required if good ventilation is maintained.

Personal Protective Equipment

Eye protection: Chemical-splash goggles.
Hand protection: Chemical-resistant gloves. Includes: Neoprene gloves.
Skin and body protection: If major exposure is possible, wear suitable protective clothing and footwear.
Respiratory protection: If aerosols, mists, or vapors are not adequately controlled by ventilation, use appropriate respiratory protection to avoid over-exposure. A respiratory protection program that meets OSHA's 29 CFR 1910.134 and ANSI Z88.2 requirements must be followed whenever workplace conditions warrant a respirator's use.
